PRESENTATIONS FROM INVITED GUESTS

EXECUTIVE SESSION

- ThermaSolutions request to extend date of LIFT award commitment.
- Imricor Medical Systems request to extend the LIFT loan draw period. The Committee requested Imricor present an update during the next LIFT Committee meeting.
